President's Corner

The California fire situation has produced considerable news coverage recently. The losses are difficult to comprehend, at least for folks like me with a South Dakota background. But I can think through a few things and wonder what will happen.

With all the homes burned, a lot of people have no place to live and their future is a big question mark. Another situation is property taxes, and what happens to property values and government revenues when structures are reduced to ashes on a widespread area. I can imagine some tense board meetings in the near future. Then there would be all the utilities that serve the area. The sudden loss of customer base and revenue would put those businesses in a difficult financial scenario. Another facet of the problem would be all the outstanding loans on the properties. Financial institutions are headed for tremendous stress there. And from what I read the insurance coverage situation has been a problem for some time, which will cause further economic pain. The list could go on and on.

If you want some perspective from history there is plenty of interesting reading about the great Chicago fire of 1871. My great grandfather was involved in some of the rebuilding activity in the city after that fire. Subsequent generations remember him describing the work as being very dangerous at times. Some years later he bought the farm here sight unseen and moved to South Dakota.

A few years back we had a long dry spell during the winter. There were random ditch fires up and down I-29 which runs along the west side of the farm. One night we watched wind driven flames burn the grass in the ditch in a steady northward movement. Eventually I had to go drive around the

section and see what happened, thankfully the fire crews won the battle. Both of my sons are involved with the volunteer fire department, and they had stories to tell the next day. There was much speculation about what started the ditch fires, as I recall tossed cigarette butts and dragging safety chains were the common suspicions.

Heading into winter in conversations someone would ask how harvest went. 2024 harvest was somewhat unique in that there were no rain or storm delays, dry weather from start to finish. After a few fire calls, the fire department put out word to farmers requesting tractors and disks be prepared for action, and a list was compiled of who to call in the event equipment was needed. We took our tractor and disk along to every field along with the harvest equipment, and thankfully never had to use it for fire activity. There were also a few days where strong winds caused us to shut down harvest activity, wait for calmer conditions with less risk of fire getting out of control.

Hopefully by the time you read this the California fires will be history and people out there can begin the rebuilding effort. Be thankful for what you have, and stay safe.

2025 SDATAT SCHOLARSHIP PROGRAM

The South Dakota Association of Towns & Townships is offering one \$1500, one \$1000 and one \$500 scholarship to three senior high school students who reside in South Dakota, are currently attending a South Dakota public, private, parochial high school or a home school program, and lives in a town or township that is a **current member of SDATAT**. (A membership list is available on the sdtownships.com website) or contact your local town/township board. Graduates of the class of 2025 are eligible to apply for the scholarship. The student must use the scholarship for a college, university, or vocational school which has a physical presence in South Dakota.

Applicants must complete an application form and submit it along with their essay on this year's topic:

Cultural values have become an important topic of discussion in the United States and our world. What are your thoughts on this trend? Identify some of those cultural trends and its effect on you. After interviewing someone that has helped develop your personal values, share your thoughts. Discuss what actions you can take to positively impact your local government and South Dakota.

Guidelines for the essay are:

- Essays must be no more than 500 words, and must be typed with double spacing.
- Applicants should **not include** identifying information such as their name, school, town or township, or their local
 officials anywhere in the essay or on the essay itself.
- Essays will be judged on: following guidelines, originality, depth of subject matter in relationship to the title, correct grammar, spelling, and punctuation. The application may be accompanied by no more than two, one-page support letters.

The completed application, typed essay, and letters of support, if any, should be submitted in one envelope addressed to: SDATAT Scholarship, PO Box 903, Huron, SD 57350.

Deadline for the application is April 1, 2025. No late applications will be considered.

The scholarship award will be paid to the appropriate financial aid office upon notification of enrollment at a SD college, university, or technical school in September of the winner's second year of study.

Non-Owned Auto Liability Coverage

A few years ago, I reviewed non-owned auto liability coverage, and I would like to touch base on this coverage again. Unfortunately, the cost for this coverage is doubling in 2025, increasing from \$100 to \$200. I felt it is important to review this coverage again, so as a board member, you are aware of what this policy covers and can make an educated decision whether the township wants to keep this coverage.

Non-owned auto liability comes into play if a board member or any employee has an accident while on township business. The board member might be out checking a culvert, or going to a meeting, or even in the courthouse parking lot while dropping off annual paperwork. If they have an accident under these circumstances, their own personal insurance would be the first to respond, investigate the claim, and pay damages if the driver is liable.

That might be the end of it, and the claim is done with no further issues. But if the claimant discovers that the township employee/board member was on township business and decides to sue the township, the non-owned liability will give coverage for the township.

Please keep in mind, the township's general liability policy would not cover this kind of situation. Claims involving the operation of a vehicle are specifically excluded, not covered, under the general liability policy. Also, please note, this does not give coverage for damage to the board member's vehicle, nor does it give coverage for the board member's injuries. It is strictly liability coverage for damage to the other person's vehicle and

for the other person's injuries. We do not have a way for a board member's vehicle to be covered under the township's insurance. And for coverage for a board member's injuries, the township would have to have a workers compensation policy.

I am always sorry to see rate increases. As you likely see on your own auto, farm or ranch policies, insurance rates are going up, and this is just one more example. I do feel this is important coverage to have; as a business owner, I have non-owned auto liability coverage and wouldn't dream of operating without it. But as a board, if anyone has concerns about this coverage, it definitely needs to be discussed. Hopefully this article provides the information you need to make an informed decision.

Basics of Contractor's Excise Tax for Townships

Townships provide many important services for their residents and townships may hire a variety of contractors to aid them in providing these services.

South Dakota townships organized under SDCL Title 8 are governmental entities exempt from South Dakota sales and use tax. Townships should provide an exemption certificate to the vendor and the vendor must keep documentation to show the purchase was paid from government funds. Documentation may include a purchase order or a check stub.

It's important to note that the exemption from sales and use tax for governments does not extend to the purchase of products or services for the personal use of officials or members of the township. Employees or representatives of the township cannot buy products or services without paying sales tax if they use a personal check or credit card. This is true even if the township later reimburses the employee.

Contracts for services that include construction, building, installation, or repair of a fixture to real property are subject to contractor's excise tax. Unlike sales tax, there are no exemptions from the contractor's excise tax.

If a township hires a contractor to perform construction services or realty improvement work for the township, the contractor will owe excise tax on the gross receipts from that work. In addition, the contractor will owe sales or use tax on all materials they use in the project. The contractor must pay use tax and contractor's excise tax on materials supplied by the township for use in their work.

A township may NOT issue an exemption certificate to a contractor that is performing construction services or realty improvements. State law allows contractors to list their tax expense as a separate line item on all contracts and bills. The contractor's excise tax and the contractor's use taxes are part of the contractor's total bill and are collectible from all entities, both public and private.

Examples of realty improvement subject to contractor's excise tax include:

Culvert installation

Blading of roads

Installing sidewalks or crosswalks

Installing streetlights

If the township makes realty improvements on its own property with its own employees, the township does not owe contractor's excise tax if no charge is made for the improvement. However, like any other contractor, when a township performs construction services or makes a realty improvement and charges a customer for the work, the township is responsible for the contractor's excise tax and must have a contractor's excise tax license.

Township supervisors <u>must procure bids</u> for supplies and services \$50000 or more and public improvements \$100,000 or more.

- This includes the cumulative cost of "similar or same" supplies and service over 12 months.
- This includes the cumulative separate bids of a single project over \$100,000.
- If all bids received are "rejected", advertising for a rebid must take place.
- Having a "bad feeling" is not an acceptable reason to reject a bid award
- Rejected bids must have valid documentation and recorded in clerk minutes
- Negotiation is acceptable only when "no firm bids" are received

In leu of bidding and going "As Needed" for supplies and services

- The anticipated cost of supplies and services must be under \$50,000 in total for fiscal year.
- The township must have a written "procurement policy" that is adopted and followed
- Quotes obtained and accepted must be prudent
- Keep in mind FEMA documentation requirements
